

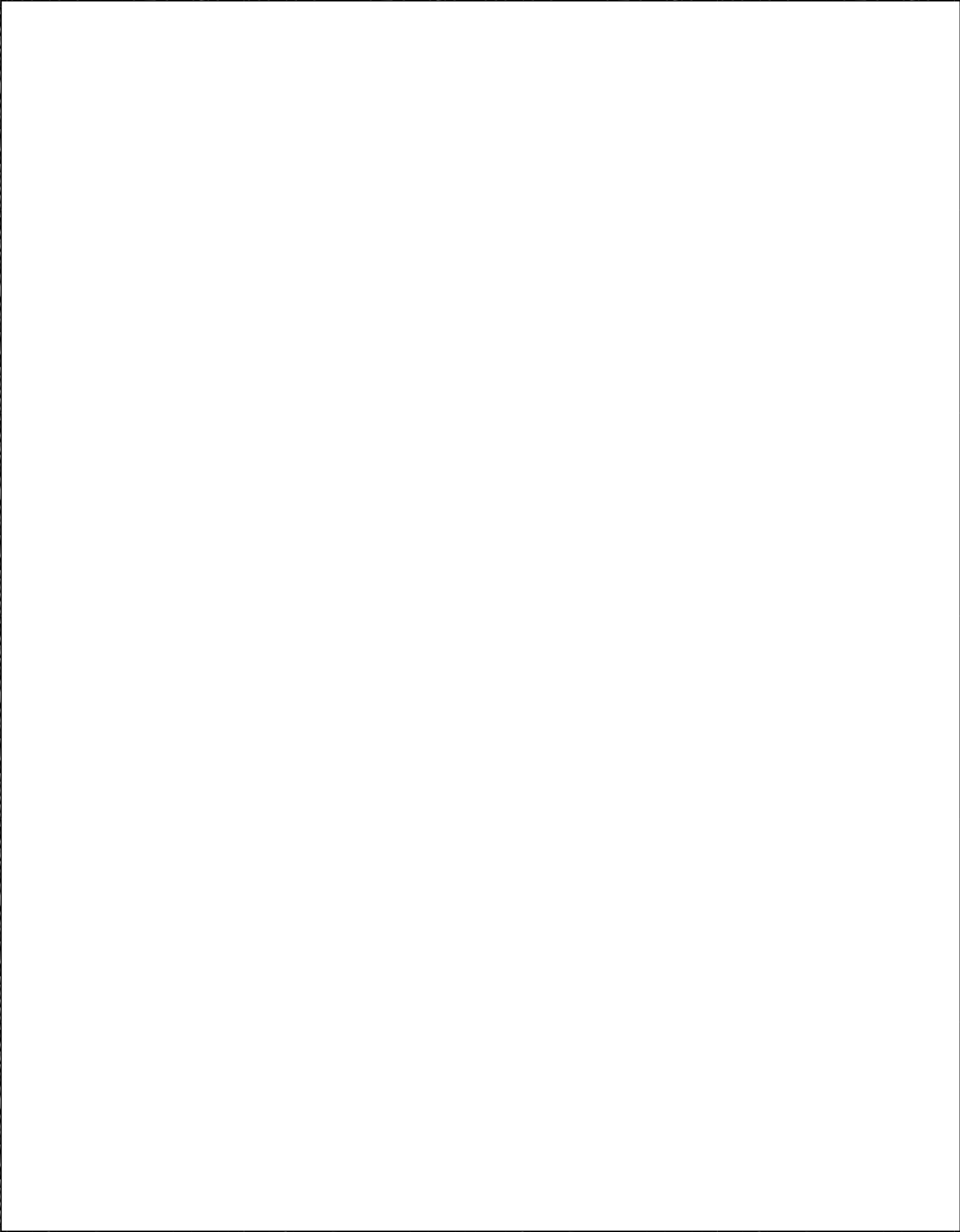

ENGLISH-LANGUAGE SCHOOL BOARDS



The analytical index is an alphabetical listing of approximately 150 topics which are related to the application of the collective agreement or which are commonly used in labour relations.

Each main subject is noted and then related to the context or contexts in which it is used. The word or phrase associated with the subject that qualifies it most directly is listed first. Where applicable, other words or associated phrases serve to clarify the different contexts that relate to the main subject. Subdivisions were added in order to make it easier to find the location of the material sought. Please note that the title appears in its nominal form; other forms of the word (adjective, plural, verb) are understood.

The numerical references that follow the subject or the associated subject or phrase indicate the number of the clause or clauses that refer to the subject in question. When the reference is in **bold characters** it refers to the definition of the subject and to the article or to the main clause that treats this subject. In all cases reading of these clauses is necessary for the proper understanding of the subject in question.

Whenever possible, generic terms such as “professional” or “school board” were omitted in the text. They are implied wherever suggested by the context.

How to Use the Index

+ *First determine the subject to research; then find and read the definition and suggested references carefully. To further your knowledge of the subject, read the references for the associated words or phrases.*

+ *If you have a computerized version of the index, open it, go to the “search” function and enter your subject. Once the main reference is found follow the abovementioned instructions.*
